D. Following the defendant's jury trial in the Superior Court for the Judicial District of Waterbury, Geographical Area No. 4 at Waterbury, *Harmon, J.*, the defendant was convicted of possession of narcotics with intent to sell, in violation of Conn. Gen. Stat. § 21a-278 (b), sale of a controlled substance within 1500' of a school zone, in violation of Conn. Gen. Stat. § 21a-278a (b), possession of drug paraphernalia, in violation of Conn. Gen. Stat. § 21a-267(a), possession of narcotics, in violation of Conn. Gen. Stat. § 21a-279 (a), and interfering with an officer, in violation of Conn. Gen. Stat. § 53a-167a. He was sentenced to 20 years incarceration, suspended after 10 years, with 8 years mandatory minimum, and 5 years probation. The defendant is incarcerated.


